1. RESOLUTION TC25-195: To consider and act upon a resolution that would appoint Lori Hayes-O'Brien of 103 Old Tree Farm Lane as a member of the Senior/Community Center and Library Study and Building Committee.
2. RESOLUTION TC25-196: To consider and act upon a resolution which would authorize First Selectman Timothy Herbst to execute any agreements or take any necessary steps to acquire 1.71 acres of real property known as part of the Hansen subdivision on Huntington Turnpike and contiguous Mischee Brook Park and incorporate said parcel into Mischee Brook Park.

3. RESOLUTION TC25-197: To consider and act upon a resolution which would abandon the Town of Trumbull's interest in and discontinue its public use of portions of Stuart Place and Lorraine Street and authorize First Selectman Timothy M. Herbst to execute all necessary agreements and documents to effect the same.
