NOTICE is hereby given that the LEGISLATION & ADMINISTRATION COMMITTEE of the Trumbull Town Council will hold a regular meeting on Thursday, November 1, 2012 at 7:00 p.m. at the Trumbull Town Hall, for the following purpose:

3. RESOLUTION TC24-83: To consider and act upon a resolution which would approve the funding for a labor contract between the Town of Trumbull and AFSCME, LOCAL 818 – COUNCIL 4 (Trumbull DPW Supervisors) beginning July 1, 2012 and ending June 30, 2017 is hereby approved.
3. RESOLUTION TC24-82: To consider and act upon a resolution which would amend Chapter 18 Taxation of the Trumbull Municipal Code to create Article IV a Business Tax Incentive Program. (Public Hearing)

3. RESOLUTION TC24-91: To consider and act upon a resolution which would authorize the Town Attorney to settle a claim known as Barbara Falkowski v. Town of Trumbull.

RESOLUTIONS

1. RESOLUTION TC24-83: BE IT RESOLVED. That funding for a labor contract between the Town of Trumbull and AFSCME, LOCAL 818 – COUNCIL 4 (Trumbull DPW Supervisors) beginning July 1, 2012 and ending June 30, 2017 is hereby approved.
2. RESOLUTION TC24-82: WHEREAS, the Town of Trumbull adopted Resolution TC19-211, an ordinance to create the Town of Trumbull Assessment Fixing Program; and

WHEREAS, the Trumbull Economic and Community Development Commission endorses and recommends the Town of Trumbull Business Tax Incentive Program Ordinance to replace the Town of Trumbull Assessment Fixing Program;

NOW THEREFORE BE IT RESOLVED AND ORDAINED, that Chapter 18 – Taxation, of the Trumbull Municipal Code is hereby amended to include Article IV, a Business Tax Incentive Program (see attached).

3. RESOLUTION TC24-91: BE IT RESOLVED, That the Town Attorney is hereby authorized to settle a claim known as Barbara Falkowski v. Town of Trumbull.
