MINUTES Senior/Community Center and Library Study Building Committee August 20, 2015

Committee members took a moment of silence in memory of fellow committee member Dr. Anthony Timpanelli who passed away on August 14, 2015.

Moved by Ms. Yahwak, to amend August 6, 2015 minutes with two spelling corrections, seconded by Mr. Marconi.

Moved by Mrs. Stauder to accept the minutes of August, 6, 2015 with corrections, seconded by Mr. Seaman.

Mr. Pifko shared that the Senior Center Study Survey is up and running as of 8/19/15 and that there are 109 responses so far and not many seniors have yet responded.
