## VOTING IN CONNECTICUT

### WHO MAY VOTE:

You may vote if you are (or will be by Election Day): a U.S. citizen, a bona fide resident of any Connecticut town and at least 18 years old (17 year-olds may pre-register up to one year before an election), and a registered voter.

Notify your registrar Trumbull. **Re-register if you change your name or if you move, either within Trumbull or to any new Connecticut town.**

### WHEN CAN YOU REGISTER?

Any time up to noon the day before a primary, or up to the 7th day before an election; if you become eligible after that, any time up to the last weekday before the election. You can also register on Election Day at the central registration station in Town Hall.

### WHERE DO YOU REGISTER?

Register in PERSON at:

- The office of the Town Clerk or Registrar of Voters in ANY city/town hall in Connecticut during normal office hours. Registration is forwarded to the Trumbull Registrars of Voters. On Election Day, Trumbull has a special registration office in Town Hall.

- Any office of the following Departments: Motor Vehicles, Social Services, Aging, or Labor; the State Library, the U. Conn. library, and the other state college libraries. **If you register through any of these departments, it is a good idea to check with your local registrar of voters (203-452-5058 or -5059) at least two weeks before Election Day to see if your form was received.**

Register BY MAIL by getting an application from the office of Town Clerk or Registrars, filling it in, and returning it to the Trumbull Registrars of Voters at Town Hall, 5866 Main Street, 06611.

Register ONLINE via the State of Connecticut Online Voter Registration System at [www.sots.ct.gov](http://www.sots.ct.gov).

### WHEN DO YOU VOTE?

Polls are open from 6:00 a.m. to 8:00 p.m. Primaries for regular elections are held on the fifty-sixth day before an election.
