## SANITARY SEWER INSTALLER CONTRACTOR REGISTRATION/LICENSE APPLICATION

### TO ALL SANITARY SEWER INSTALLER CONTRACTORS:

No sanitary sewer installations can be done in the Town of Trumbull unless your Certificate of Liability Insurance, State of Connecticut's Plumber's License and a Bond for Sanitary Sewer Connection with the Town of Trumbull are currently in effect and up-to-date.

Registrations/Licenses will not be issued if there are any outstanding monies or other outstanding obligations due to the Town of Trumbull by the Sewer Installer Contractor.

To REGISTER as a Sanitary Sewer Installer in the Town of Trumbull the following is required:

- A SANITARY SEWER INSTALLER LICENSE annual fee of \$25.00.  
(Checks shall be made out to - The Town of Trumbull)
- A current copy of the Sanitary Sewer Installer's CERTIFICATE OF LIABILITY INSURANCE.
- A \$5,000 BOND FOR SANITARY SEWER CONNECTION with the TOWN OF TRUMBULL (See Attached Bond Form)
- The SANITARY SEWER PERMIT fee is \$25.00.

KNOW ALL MEN BY THESE PRESENTS, That \_\_\_\_\_

as Principal, and \_\_\_\_\_ as surety are held and firmly bound jointly and severally unto the Town of Trumbull, and the State of Connecticut, in the sum of **Five Thousand (\$5,000.00) Dollars** to be paid to the Town of Trumbull and/or the State of Connecticut, for which payment well and truly to be made, we hereby bind ourselves, our heirs, executors, administrators, successors and assigns firmly by these presents.

THE CONDITION OF THIS OBLIGATION IS SUCH THAT WHEREAS the Principal has made application to the Water Pollution Control Authority of the Town of Trumbull for Registration to make openings and excavations in the public streets, highways, sidewalks and alleys within the Town of Trumbull under permits there for which may be issued from time to time by said Commission and whereas said Commission is prepared to issue such Registration to the Principal pursuant to Section 10a of the Town Code of the Town of Trumbull.

WHEREAS said ordinance provides that qualified excavators and utility companies may in lieu of a cash deposit for each permit applied for, file with the Sewer Commission of the Town of Trumbull, an annual bond in the amount of **Five Thousand (\$5,000.00) Dollars**.

NOW THEREFORE, if the said \_\_\_\_\_ shall well truly keep and perform all the terms and conditions of the aforesaid ordinance as the same may be amended from time to time, any conditions set forth in the application filed pursuant thereto, and any conditions attaching to any permit issued pursuant to said ordinance and any applicable rules or regulations of the State Highway Department and shall forever indemnify and save harmless the Town of Trumbull and the State of Connecticut and all their respective agents for, or on account of, any damages to property or to any person or persons, or any damage to any utilities furnish in the Town of Trumbull in consequence of, or resulting from any work performed by said Principal \_\_\_\_\_ servants, or agents until the expiration of the maintenance period; shall faithfully perform said work in all respects and shall also replace and restore that portion of any street in which said applicant, his servants or agents shall make any excavation, to as good condition as that in which the same was before said work was performed, and shall also keep and maintain such street in like good condition to the satisfaction of the Town's Agent for the period of not less than one year after completing said work and, should the Town's Agent or other official within said period, and after notice to said Principal, repair said portion of such street, the Principal shall pay the cost thereof within thirty days and shall comply in all respects with the rules and regulations established by the Town's Agent relative to such work, and the terms of the permits that may be issued to him, and shall also pay all fines or penalties imposed upon him for violation of any such rule or regulations, then this bond shall be void but otherwise shall remain in full force and effect.
