### Trumbull Police Commission Meeting January 13, 2026 MINUTES

The Trumbull Police Commission meeting was called to order at 5:30 p.m. with the recitation of the pledge and moment of silence for deceased police officers and emergency personnel.

#### **Public Comment**

No members of the public were present to speak.

#### **Approval of Minutes**

**Motion** by Vice Chairman Magliocco, seconded by Commissioner Trefz to approve the October 23, 2025 minutes. There was no discussion, all voted in favor, and the motion carried.

**Motion** by Commissioner Trefz, seconded by Vice Chairman Magliocco to approve the November 18, 2025 minutes. There was no discussion, all voted in favor, and the motion carried.

**Motion** by Vice Chairman Magliocco, seconded by Commissioner Trefz to approve the December 9, 2025 minutes. There was no discussion, all voted in favor, and the motion carried.

### **Correspondence**

Chief Lombardo reviewed correspondence items which included a memo from Sgt. Fedor complimenting Dispatcher DeSanty, Officer Goldstein, and Officer VanFleet for their competent response to the recent firearm discharge at the Trumbull Mall. Chief Lombardo provided a recap of the incident. He praised the officers for their professionalism, and he noted that the Detective Bureau is investigating the incident. Commissioner Trefz mentioned that he was shopping at the mall before Christmas, and he was impressed with the police and security presence. Chief Lombardo stated that Assistant Chief Byrnes maintains regular contact with mall management.

Chief Lombardo then reviewed other letters of thanks from various sources regarding a stolen tractor that was recovered, a Heroes & Helpers event, the Jingle Bell Run, and Fairfield's Santa Con event.

### **Chief's Report**

Chief Lombardo reviewed the following reports for the month of December: calls for service, criminal incidents, motor vehicle enforcement, incident statistics, school resource officer, K-9, juvenile arrests, adult arrest summary, traffic, detective division, training, cadet report, social worker, sick/injury, personnel count, and budget.

Chief Lombardo reported a 15% increase in motor vehicle thefts and a 41% decrease in thefts from vehicles. He also noted a 13.5% increase in motor vehicle stops, a 5% increase in motor vehicle warnings, and a 45% increase in motor vehicle arrests. He stated that these motor vehicle numbers show that officers are quite active throughout the town.

Chief Lombardo noted that several officers were trained in the use of Faro electronic devices, which will be used for measurements and mapping in accident reconstruction and crime scene investigations.

Chief Lombardo advised that the Department was awarded Tier II and Tier III accreditation from the Connecticut Police Officer Standards and Training Council. He praised Capt. Allen, Lt. Driscoll, and Lt. Smith for their contributions to this achievement. Vice Chairman Magliocco stated that he is especially appreciative that these officers accomplished this without hiring outside help, as other area police departments have done.

Chief Lombardo stated that the Department now has 80 sworn officers, ten of whom are currently in training. There was then a short discussion regarding hiring and retention.

## Police Commission Meeting Minutes, January 13, 2026

Chief Lombardo announced that the promotional test for the rank of detective was posted today.

Chief Lombardo mentioned that a new social worker started work in mid-December, and she is doing well. Commissioner Trefz asked for a copy of the social worker's job description, and Chief Lombardo replied that he will have that sent to the Commissioners.

Chief Lombardo advised the Department will likely be over-budget in overtime expenses. He noted that summer weekend double-time payments and FTO premiums are contributing factors to this overage. Assistant Chief Byrnes provided the Commissioners with a chart comparing this year's overtime expense to last year's.

### **Old Business**

Chief Lombardo and Captain Allen presented the updated towing policy. They advised that the most notable changes are reductions in the amount of storage space tow companies are required to have, and an increase in the allowable distance from Town Hall for towing companies' places of business.

There was a short discussion regarding the various aspects of towing.

**Motion** by Commissioner Trefz, seconded by Vice Chairman Magliocco to accept the towing policy as presented effective January 1, 2026. There was no discussion, all voted in favor, and the motion carried.

Chief Lombardo advised that he and Assistant Chief Byrnes have been meeting with the police union on a regular basis for contract negotiations, and progress is being made.

### **Adjourn**

**Motion** by Vice Chairman Magliocco, seconded by Commissioner Trefz to adjourn. There was no discussion, all voted in favor, and the motion carried. The meeting adjourned at 6:15 p.m.







### Calls For Service - 2025










### Criminal Incidents - 2026

### TRUMBULL POLICE DEPARTMENT DETECTIVE DIVISION

#### New & Completed Investigations

**Threatening-** On January 24, 2026, the patrol division took a complaint of a threatening letter that was received by M&T Bank. The letter was retained as evidence and a further investigation into the origins of the letter and content of the threat is being conducted.

**Suicide-** On January 15, 2026, detectives responded to the parking lot of the AMC Movie Theater on Quarry Road for a report a male that suffered a self-inflicted gunshot wound. Detectives assisted with processing the scene.

**Trumbull Mall/ Banter- Piercing Pagoda Smash & Grab-** On January 11, 2026, officers responded to the mall for a report of two suspects that used tools to smash the glass display cases of the kiosk. The investigation is ongoing.

**Trumbull Mall/ Gift Novelties Smash & Grab Attempt-** On December 30, 2025, patrol officers responded to the Trumbull for a report of a vandalism. The Gift Novelties kiosk reported that their glass display had broken glass. A review of video surveillance revealed that a masked and gloved suspect entered the mall with a hammer like object striking the glass case over a tarp covering the case in an attempt to steal the merchandise. Video surveillance has identified a suspect vehicle. The investigation is ongoing.

**Trumbull Mall/ Banter- Piercing Pagoda Smash & Grab-** On December 27, 2025, patrol officers responded to the Trumbull Mall for report of a burglary. The Banter- Piercing Pagoda kiosk was found by Trumbull Mall staff to have been burglarized by smashing the glass cases containing their merchandise. A review of video surveillance was obtained and revealed suspects

and a vehicle that were used in theft. Similar suspects and vehicle were used in an earlier burglary/ theft at the CT Post Mall in Milford. The investigation is ongoing.

**Attempt Assault with a Firearm & Fight at Trumbull Mall-** On December 26, 2025, the patrol officers and officers working a special assignment/ duty at the Trumbull Mall responded to a shots fired call. It was quickly determined that an unknown masked male had fired one round from a handgun at an intended victim. The investigation is ongoing.

**Attempted Fraud-** On September 4, 2025, the patrol division took an attempted fraudulent debit card transaction at Chase Bank on Quality Street. Patrol Officers were able to obtain video surveillance and recover as evidence a cell phone that was left behind by the suspect. The cell phone was processed for evidence and produced a suspect. The CT State Laboratory produced information on a suspect. Several search warrants were also completed by detectives that helped confirm the identity of the suspect. An arrest warrant was applied for and submitted to court.

**Incident Categories Addressed**

- Welfare Checks / person in distress – 2
  - PSW followed up with mother of juvenile. PSW provided resources.
  - Ofc. Referral regarding driver that had some cognitive issues.
    - Reached out and no response.
- Domestic or family related disturbance (verbal/noncriminal)- 6
  - PSW outreached to 4 different victims and no response
  - PSW provided 2 victims with necessary phone numbers, resources and support.  
Both declined additional support.
- Behavioral health crisis (non-medical)- 8
  - PSW outreached to several parents of adult/juvenile children who were having a mental health crisis experiencing suicidal ideation. 4 were non responsive.
  - Spoke to parent of adult child and provided information regarding discharge planning from hospital and to call when plan is complete to then discuss how that looks in the community.
  - Adult child admitted to hospital – PSW spoke to parent and encouraged to have a meeting with hospital team.
  - Suicide – PSW initiated contact with wife and then referred to PSW in Fairfield.
    - PSW spoke to 1 witness and provided trauma informed support. PSW provided other resources and support groups.
    - PSW contacted the Theatre and RD Scinto managers. Outreached to see if they needed any additional support.
  - Mother of adult child having a crisis. PSW spoke to person several times, provided research/information regarding a specific service that is required by the court. PSW continues to work with mother until complete.
- Juvenile or school-related matter – 2
  - Both cases, school was involved. PSW spoke to SRO to confirm juvenile was on their radar and if PSW needed involvement that someone will call.
- Housing instability / transient assistance – 1

- Resident sought out PSW. PSW provided shelter options, how to apply for section 8. Difficult to work with, as person was residing in a different town due to homeless status.
- *Substance-related concern (support-oriented)* – 2
  - PSW attempted to make contact and when did, provided resources related to Substance use, cannabis education as well as where to obtain safely (Dispensary), prevention education.
  - PSW referred case to Bpt PSW
- *Elder welfare or care concern* – 0
- *Community assistance / service referral* – 2
  - PSW attempted to outreach, but no return call/response
  - PSW follow-up with a concern – Complainant stated was a bad time and would call me back – no call back.


