NEW BUSINESS OPENED at 7:04 pm

Application 25-42

Town of Trumbull

Permit approval to construct a new middle school and demolition of existing school; including parking, landscaping, playing fields, site lighting, stormwater management and utility improvements within a regulated area at 530 Daniels Farm Road.

Michael Scott of TSKP Studios said this project was approved by referendum in November 2024. The new school will be constructed to the south of the existing one. The common large spaces will be a single story wing; classrooms will be in a 3 story building. It is in design development now. Brian Phillips, P.E. with Langan provided an overview of the project. Wetlands were delineated with the aim to stay out of them. The vast majority of stormwater will drain towards the wetlands. There will be 2 new parking area, new playing fields with minor grading encroachment. Approximately 3 trees will be removed. With new design water quality will be improved. A robust program of trees will be planted in the parking lot and along the wetland and upland review area. Erosion controls will be installed and monitored during the project. The construction will be phased. They have begun the process to obtain the stormwater general permit as required. In response to the Commission the following were discussed: the brook that is filled will not be affected; it was suggested designated wetlands be designed for educational learning, erosion control measures will be monitored, the fill to be brought in will be certified, there will be a decrease in imperviousness and the wetlands #2 shown on the map is well outside of scope of project.

Application 25-43

Aris W. Stalis

Permit approval for restoration & reconstruction of existing residence; landscaping, replacing driveway & front walk and installation of stormwater retention system within a regulated area at 201 Old Dike Road.

Aris Stalis, Aris Land Studio LLC presented an overview of the project. He said the site was surveyed and wetlands were flagged. The site is stabilized currently. They want to add a 2nd story to existing building. The foundation and current walls will remain as well as the stone wall. A cultex detention system will be installed and is well over what is required. A series of native plantings will be planted around the perimeter. The driveway will be repaved. The IWWC Agent suggested a landscaping bond in the amount of \$28,000 as well a site monitor.
