Application 26-02 Joseph Juliano

Permit approval for an inground pool within a regulated area at 17 Apple Gate Lane.

Tracy Chalifoux, Landscape Architect for the project provided an overview of the project. She said the previously required wetland restoration plan has been implemented and is finished that included the raingarden, demarcation boulders, wetland plaques, native wetland plants and stormwater system. This application is for a 16'x34' inground pool and patio. Manny Silva, Professional Engineer went over the stormwater system. Runoff will be reduced. There will be riprap spillway. Silt fence will be installed to protect the site; there will be a stockpile area and concrete washout area. A play area will be added that will be a pervious area.
