PLANNER'S REPORT

IL-3 Master Plan Presentation

Rob Librandi, Land Use Planner, remarked that Stantec was hired to undertake a Master Plan Study of the IL-3 Zone which is the area of Merritt Boulevard. The goal was to discover what is needed to make the area more vibrant.

Gary Sorge of Stantec displayed a Power Point Presentation of the study by sharing his screen. Key aspects of the study were highlighted and presented. The draft document was posted online on the Town of Trumbull website.

Chairman Garrity and Rob Librandi thanked Gary Sorge and Stantec for their work.

Governor’s Executive Order 7-MM – Outside Activities
