**AMENDED HEARING MINUTES**

**Town of Trumbull  
Board of Assessment Appeals**

A meeting of the Board of Assessment Appeals of the Town of Trumbull, Connecticut was held in the Nichols Room, Trumbull Town Hall on September 10, 2025, at 3:00pm.

The meeting covered assessment appeals for Motor Vehicles on the Grand List of October 1, 2024.

Present during the meeting was Chair; Gail Ayotte, Board Members; Jeffrey Craw, Tony D'Aquila, and Alternate; Dean Fabrizio.

Chair Ayotte called for approval of the minutes from the Board's meeting in April of 2025. Jeffrey Craw approved. Tony D'Aquila abstained stating he did not receive the minutes. He was shown the email that was sent with his email address listed and reminded that all minutes are posted on the town website.

Chair Ayotte revisited several procedural concerns brought to the Board by Tony D'Aquila at the April meeting. Mr. D'Aquila requested answers from the town attorney in writing. Chair Ayotte, with permission of the attorney, sent an email dated May 1, 2025 that included answers in writing from Daniel Schopick, as well as a summary of all procedures & guidelines in question. Gail Ayotte requested acknowledgement of receipt of the email and understanding from Board members on procedural explanations from the town attorney. Jeffrey Craw acknowledged receipt and understanding. Dean Fabrizio (Alt.) acknowledged receipt and understanding. Tony D'Aquila said he was "not comfortable" acknowledging or accepting guidelines as he did not remember receiving the email. Chair Ayotte gave Tony a printout of the email thread and pointed out the date sent, and that his email address was included on the communication.
