### **Approval of October 12, 2021 Special Trumbull Police Pension Board Minutes**

Motion made by Trustee Thornton to approve the October 12, 2021 Special Police Pension Board minutes, seconded by Trustee Allen. There was no further discussion. Motion passed three abstentions Trustees Champion, Magliocco and Trefz.

### **Approval of Pension Calculations from BPS&M for Diane Buckley Surviving Spouse of Retiree Officer Daniel Buckley**

Trustee Coppola informed the Board retiree Officer Daniel Buckley passed away on November 12, 2021. Mr. Buckley has a surviving spouse, she is entitled to receive half of Mr. Buckley's monthly pension as he retired under Veteran's Reserve. Actuary Brad Fisher of PBS&M was contacted for review of the monthly pension Mrs. Buckley is to receive. Per Mr. Fisher

he indicated Mrs. Buckley is to receive fifty (50%) percent of Mr. Buckley's monthly pension which would be \$1,890.85 per month.

Trustee Coppola explained since retiree Buckley passed away in the middle of November the Board as a courtesy does not request for the November pension to be returned. Mr. Buckley's brother-in-law (Richard Jesuroga) has the power of attorney for Mrs. Buckley. Due to receiving notification of Mr. Buckley's passing after the deadline with Wells Fargo to stop the December 2021 monthly check Mrs. Buckley received it. Options were provided to Mrs. Buckley to return the December 2021 monthly pension check and a new check would be sent to her with what she is entitled too. Mrs. Buckley was also give the option to keep the December 2021 monthly pension which would cover December 2021 and January 2022 monthly pension. Mrs. Buckley would then in February 2022 would begin to receive her monthly pension check of \$1,890.85. Per Mr. Jesuroga, Mrs. Buckley decided to keep the December 2021 monthly pension check and begin in February 2022 to receive her monthly pension check.

Motion was made be Trustee Coppola to approve the monthly pension of \$1,890.85 as presented and reviewed by Actuary Brad Fisher for Mrs. Diane Buckley effective February 1, 2022, seconded by Trustee Thornton. There was no further discussion, motion passed unanimously.

**Approval of 2022 Trumbull Police Pension Board Meeting Schedule**

The Board reviewed the 2022 Trumbull Police Pension Board meeting schedule and all were in agreement with the schedule.

Motion was made by Trustee Allen to approve the 2022 Trumbull Police Pension Board meeting schedule as presented, second by Trustee Perez. There was no further discussion, motion passed unanimously.
