This addendum is to answer some questions and also a filed map.

Questions:

- 1) Can a map of the HS/MS campus be supplied designating Fields 1-15?
- 2) Can a general location be given for the remainder of the fields for inspection?
- 3) Additional services are for fields above and beyond that may be added to the contract?
- 4) During the walk through, near the pit where The Giving Tree was working, it was mentioned that irrigation was not included in the contract. Irrigation monitoring (water usage) is part of the responsibilities for certain fields, correct?
- 5) Is clay, Partac, Turface and any other required field materials supplied by the town?

Answers

The High School / Hillcrest layout is attached.

Materials for basic maintenance and wear and tear is supplied by the contractor....clay, drying agent, paint.

Additional services are to be billed under the unit pricing portion of the bid.

Irrigation is not the responsibility of the contract as far as repair and maintenance, however observation and reporting of malfunctioning heads or leaks as well as the timing schedule would be under the contractors' control.

Basic Field locations are as follows.

Madison School and Kaechele Farm Parks are located on Madison Avenue down from Lake Ave

Unity Park is off White Planes Road and Bayberry

Island Brook Park is off Wilmot Ave

Long Hill Field is off Main Street

North Madison is on Madison near Tashua Road

Nothnagle is off Shelton Road

Indian Ledge is off Whitney Ave
