**General Information:**

- Board of Education will be responsible for protecting all landscaping in scope of work areas.

**Requests for Information (RFIs):**

- Q1: Note 3 Work to be complete in 90 days from notice to proceed. Page 4 Board of Ed asking to be done by 8/23/19. Please clarify.  
A1: Some work may be completed this year as long as it is by August 23 otherwise all work is for next year.
- Q2: Will permit fees be waived by the town except the state education fee?  
A2: Yes, fees are waived with the exception of the state education fee.
- Q3: Are we required to have a field office?  
A3: No onsite office required.
- Q4: Whose locking system is in place for the Trumbull School District? The locks for this project are specified in Schlage but in my experience many if not most of the schools in New England are either Sargent or Best key system.  
A4: Trumbull Schools does not have a district-wide system at this time however there is currently a project out for bid (RFP #6308) to provide such. The new locks for this window project must match that of the new system once accepted.
- Q5: I cannot find the schedule for the blinds and shades. Where is it?  
A5: There is no schedule however Construction Notes 2 and 7 on Drawing A3 indicate locations.






