THE TRUMBULL SEWER SYSTEM

Dear Homeowner:

Enclosed is an application for you to complete regarding your request for an Extension of Time to Connect to the Sanitary Sewer System. Kindly complete the form by providing the requested necessary information. The application must be signed by the owner(s) of record.

The granting of an Extension is contingent upon approval of the Trumbull Health District. The Health District will perform an inspection of the applicant's septic system. **A Septic System Inspection Fee, currently \$135.00**, will be required when filing a waiver application. The enclosed form should be completed and returned to the office of the W.P.C.A. with a **check made payable to the Trumbull Health Department**.

An Extension of Time to Connect applies only to the present owners of the property and is available only as long as the property is owner occupied, and shall be immediately terminated should the present septic system be in need of repair. Waivers will **NOT** be available to a building after the originally assessed owner transfers the title or sells the property, except on the condition that the existing septic system is less than 15 years old. If you sell your house, a Title Search will indicate that the house is not connected. The W.P.C.A. will require the new owners to connect.

Homeowners are required to pay the Sewer Assessment whether connected or not. The granting of an Extension of Time to Connect shall have no effect upon the obligation of the property owner(s) to make all payments when due on the Sewer Assessment, which shall remain in full force. **You will also be required to pay a quarterly maintenance fee, currently \$33.00 per quarter.** Every resident with access to the sanitary sewer system is responsible for this cost whether connected or not.
